Behavior Guidelines

As youth sponsors, we desire our students to know Christ better. So, we have set out certain guidelines that we feel will help facilitate that goal. Below are listed several guidelines. Please read them together (parent and student) carefully, and if agreed to, please sign the section together on the Parent Permission Form (located on the back of this page). Without this agreement, the student will not be able to participate. Thank you.

1. Students are to show respect to God at all times, through their speech, actions, and attitude.
 - a. Swearing, foul language, sexual or otherwise, put-downs, or other language deemed destructive to the group or to members of the group will not be permitted.
 - b. Talking during teaching times, while sponsors are speaking, or during prayer times will not be permitted. This refers to constant talking, which distracts others and is disrespectful to God and others.
 - c. Students will not be permitted to leave the area of the group for unsupervised amounts of time, except for using the restroom.
 - d. Students are to bring their Bibles to each session.
 - e. Students will show respect to the sponsors that accompany them. They are to obey the guidelines set out and enforced by the sponsors, and be respectful in speech and attitude.
 - f. Students are to respect one another in their speech and actions, and are to avoid put-downs, gossip, lies, and other disrespectful talk. They are to be kind and courteous. There will be no students of opposite sexes being in a private place (such as a room) without a sponsor there. There will also be no inappropriate touching: such as holding hands, hugging, or cuddling, or any other touching between sexes that the sponsors deem inappropriate.
 - g. Every person is to dress modestly. Guys are not to wear clothes that show the stomach or chest area. Girls are to wear one piece bathing suits. No tube tops, mini skirts, short shorts, or anything that would bear stomachs or anything else. If a sponsor thinks that what the student is wearing is inappropriate, they can request that student change in to more modest apparel.
 - h. We feel these are things that show respect to God and His Word and are important in preserving our and your youth's integrity.

2. Students are to demonstrate good common sense.
 - a. Students are to be where they are supposed to be when they are supposed to be there. Camp has a schedule, even though it is flexible we need to stick to it as best we can. If student is found to be late and deciding on not coming to any of the activities that we have going on, on consistent basis, warning will be issued. This shouldn't be a problem.
 - b. Students need to be respectful of property, not only their own, but also the property belonging to others. Students are not to steal, vandalize, and other such things that cause destruction of property. Any student participating in such action will be sent home.
 - c. Students will not be allowed outside the camp without an adult sponsor. This is purely for safety reasons. There is no reason to leave other than emergencies, which will be handled by the sponsors. Violation will result in immediate dismissal from the camp.
 - d. Students may not bring drugs, alcohol, tobacco, firearms, fireworks, or other illegal substances or items on this trip. Unlike most other rules, this will have immediate and possibly legal consequences. Dismissal from the event and a parent meeting will be the required results.
 - e. Students are to be obedient to authority, such as the camp director, sponsors, and any camp staff.
 - f. Students also need to follow all of the rules of the camp. Even though they are not listed here, they will be filled in at camp during the orientation. They need to respect the wishes of the camp, failure to do so, will result in disciplinary action and student will be sent home.

Violations of the guidelines will be handled in this order, depending on severity:

1. Verbal Warning
2. Private Verbal Warning
3. Dismissal – If a student is dismissed, their parent will be called and required to bring them home. If the parent does not come to pick up their student, appropriate transportation will be provided and billed to the parent. If the parent is not home, attempts will be made to reach them or a close friend of the family for a ride home.
